**\*\*Explanation of Race Fees:** Includes race Entry Fee, \$4.00 ISDRA racer's user fee which is paid to ISDRA, \$1.00 Animal Welfare donation and \$5.00 refundable bib fee. **PLUS:** Non-Trailblazer members pay \$5.00 each class entered **OR** join Trailblazers as Associate Member for \$20. Membership form on website. [www.witrailblazers.org](http://www.witrailblazers.org) **PLUS:** If you are not a member of ISDRA a \$6.00 fee per class entered applies. Junior Classes need not be ISDRA members unless racing for ISDRA points or Trailblazer members unless racing for the Club Championship award..

**Bib/ISDRA Form Refund:** \*On Sunday bibs and ISDRA Report Forms must be turned in after racing, then \$5.00 will be refunded to racer for each entry.

**Important information for Juniors :** ISDRA Rule: At any sanctioned event, juniors may compete in either the adult division or junior division but not both, for a race of a specific competition type (i.e. sled, skijoring, etc.).

**Entry Deadline:** You must have your entry with money to Doris Lovrine by 8:00 p.m. Tuesday before the race to be entered in the draw. If not, you have until 8:00 p.m. on Thursday to enter and pay, but you will not be in the draw. You will be added to the end of the class. If you are entered and paid, then decide not to race, you have until Thursday at 8:00 p.m. to notify Doris. Your check will be destroyed. 715-479-8047

**Snubline starts – 10-dog, 6-dog, 4-dog and 3-dog junior –** Snubline must go from carabineer where gangline attaches to sled bridle to slightly beyond sled handle with about a 4" loop at end.

**Important rules:** Dog bags required in all classes except Juniors not competing for ISDRA points. Dog bags must be capable of restraining a struggling or totally covering a severely injured or dead dog and meet minimum ISDRA ventilation requirement. Dog bag must be carried on the sled. No abuse of dogs will be tolerated at WI Trailblazer races. All drivers will abide by all decisions of Race Marshall regarding any incidence. Anyone physically or verbally abusing a Race Official will be disqualified from that class. Please – no abuse of trail help. No whips allowed. **PARKING:** Please park in the same spot both days.

I acknowledge that there are risks of injury to persons or possible damage to equipment while participating in a sled dog race. I further acknowledge that I am participating in this race at my own risk. I understand that WTBSDC, and ISDRA are corporations formed to advance the sport of sled dog racing and that their efforts directly benefit me. In consideration of my being permitted to participate in this race, on behalf of myself, my heirs, assigns and personal representatives, I hereby waive, release and forever discharge WTBSDC, ISDRA, and any organizations or individuals involved in organizing and/or sponsoring this race, any involved municipalities or other public entities, and all of their employees, agents, officers, directors, attorneys, members, sponsors, promoters and affiliates whosoever from any and all liability, claim, loss, cost or expense for personal injury, death or property damage arising from or attributable in any way to any action or omission

to act of any such person or organization in the sanctioning, organizing or execution of the Sled Dog Race, or my participation therein, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above, including but not limited to travel to or from or parking at the Sled Dog Race. Knowing the above risks of sled dog racing, I nevertheless hereby agree to assume those risks and to release, discharge and hold harmless all of the persons or entities mentioned above who through negligence, carelessness or otherwise might be liable to me or my heirs or assigns for any and all damages for death, personal injury or property damage of any kind. The risks which I assume are all of those involved in participation in a sled dog race, including but not limited to those relating to trail conditions, weather conditions, passing of teams, contact between dogs and mushers on different teams or the same team, starting and finishing the race, sanctioning and officiating of the race, spectator presence at the race, announcing and timing of the race, travel to and from and parking at the race, and all other natural and manmade conditions of any kind whatsoever pertaining to or occurring at the race.
